Memorial Wall Dewlands Lane Cemetery

Introduction

The Parish Council is providing a memorial wall in the Garden of Remembrance at the Dewlands Lane cemetery for the bereaved to have a place for remembrance of their loved ones. The Council is providing a memorial wall with space for 24 plaques.

The purchaser may purchase a plaque only, or a plaque and interment of ashes within the Garden of Remembrance.

Memorial Wall Fees 2019 – 20

Plaque on memorial wall only	£110
Interment of ashes	£125
Interment of ashes and plaque	£235

Operating Principles:

1. Location for the interment of ashes in the Garden of Remembrance will be agreed by the Sexton. The Sexton's decision on the interment of ashes location will be final. The scattering of ashes is not permitted in the Dewlands Lane cemetery.
2. Plaques will be added to the memorial wall in rotation.
3. Only text may be included on the plaque.
4. To ensure installation is undertaken safely to the required standards, the Council will provide and install the memorial plaque in all cases.
5. Publicity on the Council website will provide information and an enquiry form for those interested in purchasing memorial wall plaques. The enquiry form is shown in Annex 2.

Size 150 x 50mm

Stainless steel with text engraving. (Brass is not acceptable due to theft of brass plaques).

All text must be approved by the Council. Three lines of text, maximum 75 characters in total.
