5. LOCAL PLAN PART 2 TIMELINE

Aug – Sept 2017: Consultation on preferred options and draft policies (Regulation 18)

April 2018: Publication and Regulation 19 consultation

July 2018: Submission for examination

March 2019: Adoption

Concerns were raised about the consultation over the summer holidays and the impact of the decision of the Secretary of State to call in the Dunsfold planning application on this timescale. The Clerk will contact WBC for more information, and will ask the former Neighbourhood Plan Steering Group Chairman for the Neighbourhood Plan evidence base.
