5. STRATEGIC ENVIRONMENTAL ASSESSMENT

Scoping Report

Responses from Historic England and Natural England together with a reply from the Environment Agency that they are unable to provide a response have been forwarded to Navigus planning consultants to amend the Scoping Report accordingly. A Strategic Environmental Assessment will then be prepared for Regulation 14 public consultation in November.

6. CALL FOR SITES

The Neighbourhood Plan needs to identify sites for 234 houses, of which 98 already have planning permission leaving sites for 136 houses to find. The Committee AGREED to consult on the sites with no constraints or minor constraints at the call for sites public consultation next week and will ask members of the public to rank their sites in preference order.

7. DRAFT NEIGHBOURHOOD PLAN

The Committee discussed the draft policies making some amendments and additions.

8. GREEN SPACES

The maps of the green spaces are available for the public consultation next week, where evidence of use by members of the public will be collected.

9. AREA OF STRATEGIC VISUAL IMPORTANCE

The extension to the Area of Strategic Visual Importance at Snoxhall Fields will be included in the public consultation next week.
