15. THE GENERAL POWER OF COMPETENCE

Part 1 of the Localism Act 2011 applies a general power of competence to local authorities in England. Section 1 (1) of the Act provides that "a local authority has power to do anything that individuals generally may do". The power extends to 'eligible' parish councils. Under the *Parish Councils (General Power of Competence) (Prescribed Conditions) Order 2012* (SI 2012/965), an 'eligible' parish council is one in which at least two-thirds of the members have been elected (i.e. not co-opted) and it has a qualified Clerk.

In May 2023, eight members (two-thirds) were elected and the Council employs a qualified Clerk who holds the AQA Certificate in Local Council Administration and module 7 of CiLCA 2012.
