The Personnel Committee also AGREED to recommend to the full Council for Brighton University students to use the Village Hall as a diploma case study for their business and marketing course.
- The Personnel Committee recommends to the full Council to recruit at least two further Councillors to support the Youth Council to ensure two persons with DBS and safeguarding are available for every session.
- The Personnel Committee reminds full Council to be mindful of confidentiality when discussing matters that have staff implications in public session.
- The Clerk reported on the Grounds Management Association Pay Bargaining Guide published in April 2024 which advises that for those that work in the public sector it can help to look at the pay award of the National Joint Council (NJC) for local government services. The Clerk advised that Godalming Town Council have aligned their amenity staff to the NJC. The Clerk gave a presentation on the potential alignment of the grounds staff to the NJC.
