## 1. <u>ELECTION OF CHAIRMAN</u>

Cllr A Richardson nominated Cllr E Townsend as Chairman to the Neighbourhood Planning Committee, was seconded by Cllr S Jeacock and AGREED.

- 5. NEIGHBOURHOOD PLAN COMMITTEE MINUTES

## 9. DRAFT NEIGHBOURHOOD PLAN – REGULATION 14 COMMENTS

The Chairman reminded Councillors that the Parish Council cannot duplicate Waverley Borough Council policies in the Neighbourhood Plan.

The Chairman has been through the responses from the statutory consultees and Waverley Borough Council and amended the Regulation 14 draft Neighbourhood Plan.

It was AGREED that the Council would submit the amended Regulation 14 draft Neighbourhood Plan to the planning consultant Navigus with the database of responses and comments from the Chairman. Navigus will review the responses and comments and make any recommendations for changes to the Neighbourhood Plan to be considered by the Parish Council. The Parish Council will also arrange a meeting with Waverley Borough Council to further explore their comments on the green spaces allocations in the Neighbourhood Plan.

10. <u>TIMELINE</u>

If necessary, the Parish Council will call an extraordinary meeting of the Parish Council to approve the amended Neighbourhood Plan for submission to Waverley Borough Council Regulation 15 and the Regulation 16 consultation.
