Purposes Committee for the period 2023-2027

Dear colleagues

We are seeking your assistance to co-opt <u>two</u> Town/Parish councillors to sit on the Borough Council's Standard & General Purposes Committee (S&GP). Co-optees may be members of any Town or Parish council in the Borough provided they are not also Borough Councillors.

The S&GP Committee has a key role in promoting and maintaining high standards of ethical conduct among councillors and advises the Council on adoption or revisions of its Code of Conduct and arrangements for dealing with complaints against councillors of a breach of their code of conduct.

At least one Town/Parish co-optee must be present when matters relating to Town and Parish Councils or their members are being considered, including a Standards Hearing Panel to determine whether a Town/Parish councillor has failed to comply with their Code of Conduct.

Town/Parish co-optees may not participate in matters that do not relate to Town and Parish Councils or their members.

The S&GP Committee usually meets on four evenings (6pm start) each year in the Council Chamber at Waverley's Council Offices in Godalming. All of our meetings are open to the public and press and are webcast.

I would prefer if you could please canvass your members to enquire if they would be interested in being nominated as a co-optee.

The deadline for receipt of nominations is **12 noon on FRIDAY 28 JULY 2023.** Could you please provide contact details (home address, email address, and phone number) for each nominee.

If we receive more than two nominations, I shall write to the nominees to ask them to provide a personal statement in support of their nomination by no later than 12 noon on Friday 4 AUGUST 2023. I shall then send the personal statements to all parish clerks and invite each parish council to cast one vote in favour of their preferred nominee, which should be sent to me by no later than 12 noon on Friday 25 AUGUST 2023. The outcome of the ballot will inform the Council's decision on the co-option of the parish members to the S&GP Committee.
