



Any licence (alone or jointly with others) to occupy land in the Council's area for a month or longer




Corporate Tenancies

Securities

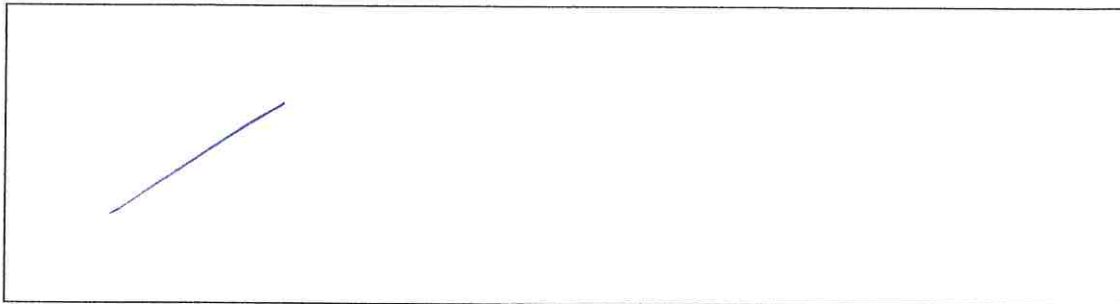
Any beneficial interest in securities of a body where—
